**C. FY 21 Annual Audit**

The FY 21 financial audit was held on August 8th and 9th. The auditor will present the findings at the September board meeting.

**D. Proposed FY 22 KASEC Budget**

The proposed budget will be brought to the Governing Board meeting for approval on August 26, 2021.

**E. New Transition Program**

The program now has five students enrolled in the Transitions program. KASEC has reached out to the community for donations to the program and the response has been overwhelmingly positive. KASEC is working on renaming the program and has been brainstorming with the staff. The director has asked the Board to reconsider their proration tuition policy on a one-time basis to accommodate a student from SACHS based on the new legislation that recently passed. The director was given the directive by the Board to allow prorated tuition for this SACHS student due to the new legislation.

**F. ESSER III**

Instead of Cooperatives receiving federal money, the State is using set-aside money for Cooperatives to close the learning gap due to COVID. KASEC is receiving \$101,113 and allocations will be divided into 60% for learning loss, 20% for after-school programming, and 20% for summer enrichment. KASEC is looking into conducting field trips for the students and has asked districts to consider setting aside some of the districts' ESSER monies to assist with the funding for transportation costs for the field trips.

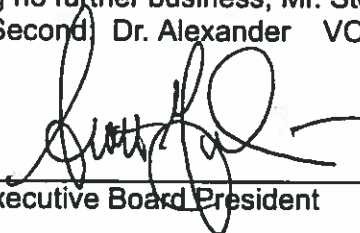
**6. ACTION ITEMS**
