5. DIRECTOR'S REPORT

Ms. Coffey's report included:

A. FY25 PRELIMINARY KASEC AUDIT REPORT

Jackie Miels from SKDO presented the FY25 KASEC financial audit report. There were no significant findings or compliance issues. During the review, she mentioned that a receipt was inadvertently deposited into the St. Anne Unit District #24 account but was not recorded. SAUD #24 subsequently remitted the funds to KASEC, and an audit adjustment was made. The net balance has increased due to the timing of revenue recognition and the transition to monthly service billing and paper bid billing.

B. 2025-2026 ENROLLMENT

There has been an influx in enrollment, and we anticipate an additional student from Donovan.

C. STAFFING

The Director presented revised OTR and COTA contracts at the August Board meeting. She is asking the Board to approve them at this meeting.

D. OPEN INVOICES

The Director reviewed the District's billing open invoices. Two districts have paper order invoices still open.

E. PROFESSIONAL DEVELOPMENT

The Director presented professional development opportunities for the area districts to participate in.

On August 27, 2025, the KASEC Governing Board approved the proposed amendment to the KASEC AJA for the membership of Momence Community School District #1. The resolution will come into effect only if it receives a two-thirds majority vote.
